Clermont Main Street, a 501C3 that provides downtown Clermont with community-driven programs focused on economic development and historic preservation. This letter is to serve to express our enthusiastic support for the City's request for community project funding for the Stormwater Improvements associated with the Meet/Middle project (8<sup>th</sup> street pier) and to advocate for the approval of the application for federal funding. This project represents a pivotal opportunity for our downtown area and the entire Clermont community.

Additional green infrastructure elements include shoreline native species and tree planting, construction of a green-roofed restroom building and installation of pervious pavement for the parking areas and promenade. The concept was presented to the SJRWMD with no issues identified and the City is moving to implement its plans.

The City is requesting Community Project funds to support the stormwater elements of the waterfront revitalization that clearly implement the goals of the Clean Water Act and are eligible under the US EPA STAG Clean Water program. We wholeheartedly support their application.

In 2015, the City of Clermont adopted a Master Plan to broaden community appeal, water quality protection, and visitor use of the degraded 8<sup>th</sup> Street Pier area on Lake Minneola, the third in the Clermont Chain of Lakes and an Outstanding Florida Water (OFW) with a "Special Water" designation. "Special Waters" OFWs are designated for their exceptional recreational or ecological significance and a finding that the environmental, social, and economic benefits of the designation outweigh the environmental, social, and economic costs.

In 2021, responding to unsafe conditions at the Pier and recognizing the environmental significance of the lake, the City Council prioritized waterfront revitalization of this area to include significant stormwater management and green infrastructure improvements. In March 2023, the community met to discuss the project, citizen feedback was incorporated into the redesign of the area, and concepts were further vetted with City residents for feasibility and accessibility.

The City is ready to move ahead with the project to include upgrading an antiquated stormwater retention area into a tiered greenspace featuring an immersive stormwater retention pond, bioswales, and native rain gardens; this green infrastructure will naturally filter stormwater and improve both the water quality and aquatic habitat within the lake. Additional green infrastructure elements include shoreline native species and tree planting, construction of a green-roofed restroom building and installation of pervious pavement for the parking areas and promenade. The concept was presented to the St. Johns River Water Management District (SJRWMD) with no issues identified and the City is moving to implement its plans.

The City is requesting Community Project funds to support the stormwater elements of the waterfront revitalization that clearly implement the goals of the Clean Water Act and are eligible under the US EPA STAG Clean Water program.

I wholeheartedly support the City's request as critical to Lake Minneola, the region, and Clermont residents.
