Re: Montverde Complete Streets Community Project Funding

Dear Congressman Webster:

On behalf of Lake County, I would like to express support for the Montverde CR455 Complete Streets community project request of \$1.5 million. This project is of crucial importance to Lake County as CR 455 is a major collector road that passes through the rural Town of Montverde.

Montverde has significant vehicular, bicycle and pedestrian traffic, and safety has been a major concern, especially with the presence of the Montverde Academy, a diverse college preparatory school of 1,200 students founded in 1912. This area of Lake County is extremely popular with cyclists, with CR 455 a heavily utilized bicycling route for recreation, cycling events and other events involving the academy, along with the permanent residents of Montverde. With Montverde Academy split by the road, there is also a significant volume of pedestrian traffic crossing this road daily. This project has been part of the County's long-range plan and is proposed to provide bike lanes, multi-use trail, sidewalk, improved street crossing, and traffic calming, as well as critical drainage improvements. This segment of road is also listed as a State of Florida Scenic Byway.

Please note, if the appropriations funding of \$1.5 million towards the total project cost of \$2 million is awarded, any required local match will covered by the County.

We welcome our continued growth in Lake County, and this funding will assist in ensuring enhanced safety for residents and visitors to Lake County keeping our County a safe place to live and work. As such, Lake County extends appreciation for your consideration of this request.
